Synopsis

Americans today live in a time of deep political polarization, cultural tribalism, and selfsegregation. Those with whom we have deep disagreements, assuming we interact with them at all, are often viewed as not just wrong but as irrational, immoral, even contemptible. What are the causes and costs of these trends? What remedies might exist? Are there habits of mind that we might cultivate to build better citizens and a healthier democracy?

Ground Rules

Together, we will build a community of trust and friendship amid political disagreement. Following the principles below will help guide us along the way.

- The Principle of Freedom: Duke University's Mission Statement affirms its foundational commitment to promoting "an intellectual environment built on a commitment to free and open inquiry," which encompasses academic freedom and free speech. These rights are sacrosanct in this class and are possessed by faculty and students alike. With the aim of advancing and deepening everyone's understanding of the issues addressed in the course, students are urged to speak their minds, explore ideas and arguments, play devil's advocate, and engage in civil but robust discussions. There is no thought or language policing. Students are expected to do business in the proper currency of intellectual discourse—a currency consisting of reasons, evidence, and arguments—but no ideas or positions are out of bounds.
- The Principle of Charity: When approaching a new idea, attempt to understand the idea sympathetically and in its most persuasive form. When you then critique the idea, focus on

the argument itself, not the person who said it. Do not attribute bad motives for other's beliefs, which they do not think they have. When disagreeing, work towards unity and towards keeping the conversation going. This means we do not cancel each other in this class. Rather than "calling out," we will "call in," which should be apparent in both the content and tone of our comments.

• The Principle of Humility: Acknowledge the weaknesses in your own arguments and privilege the pursuit of truth over "winning" the argument. Remember that we are all fallible and all of us surely hold beliefs that are wrong, though we don't know which ones. Keep your mind open to learning new things from authors and fellow classmates whose ideas you don't share.
